DOCUMENTS REQUIRED BY THE APPLICANT

- ✓ Application Form (VAT-4),
- ✓ Passport or similar document showing which country the applicant is a citizen of, a notarized Turkish translation of the certified document if the applicant is stateless.
- ✓ If a minor whose custody is with the applicant mother or father is to acquire citizenship, a document indicating the consent of the other parent must be arranged before the notary public or authorized officer in Turkey, or at the Foreign representative office abroad, or the parent must provide a certified Turkish translation of the document arranged by the relevant authorities of his/her country.
- ✓ Documents showing marital status. Marriage certificate if married, divorce document if divorced, spouse's death certificate if widowed.
- ✓ Documents showing identity details of the main applicant such as a birth certificate or civil registration document as well as a document that shows family ties with the spouse and children, if applicable.
- ✓ If the person does not have a set month and date of birth, a document must be obtained from the relevant authorities of his/her country for the completion of the date of birth and a signed declaration stating that he/she accepts the process pursuant to Article 39 of the Population Services Law no.
- ✓ A receipt showing that the service fee has been paid to the Ministry of Finance.
- ✓ 2 Biometric photographs with white background, sized 50x60 mm, as determined by ICAO

POINTS TO BE CONSIDERED WHEN FILLING THE FORM

- ✓ This form must be filled out digitally using size 8 "Arial" font. If digital completion is not possible the form must be printed and filled using ball point pen.
- ✓ If there are more than one name and surname, no abbreviations are to be made.
- ✓ The parts for identity details must be identical to details indicated in the Turkish translations of the original certified documents.
- ✓ "Turkish Name" and "Turkish Surname" parts are only to be filled if a Turkish name and surname is desired.
- ✓ If the existing name and surname are to be kept, they must be written in accordance with Turkish language rules.
- ✓ If the number of minors are more than three, a second form is to be used and only the relevant parts are to be filled and signed
- ✓ If any section of this form does not provide enough space for the necessary information please use a second form and only fill the relevant parts and sign.

WARNING!

- ✓ The form will not be processed if the information is incomplete, unreadable or unsigned
- ✓ In the event that the states constituting the basis for the acquisition of Turkish citizenship are found to be concealed or misrepresented, the decision on the acquisition of Turkish citizenship shall be canceled.
- ✓ If there are minors included in the main applicant's application for the acquisition of Turkish citizenship, they must apply together and the documents stated in Art. 38 of the Regulation on the Implementation of Turkish Citizenship Law No. 5901 for children should be added to the application documents.
- ✓ If the applicant makes false statements during the process they might face imprisonment pursuant to Article 67 of the Population Services Law no 5490
- ✓ A person who uses fake documents during the citizenship application may face imprisonment from two years to five years in accordance with Article 203 of the Turkish Penal Code .
